
# **ATTENTION! CONTEST!**

#### **REGULATIONS**

#### on the CORONA TALES

#### **Art Contest**

#### 1. General Provisions

- 1.1. The art contest of stories and pictures is held for the employees of the company, recruitment agencies, contractors working at the company's facilities, and their children as an additional measure to maintain a positive psychological atmosphere in the team in the conditions of the high alert regime in connection with the spread of the coronavirus (COVID-19) disease.
- 1.2. The contest shall be held from <u>21 April 2020 to 01 June 2020.</u> Entries will be accepted from <u>21 April 2020 to 25 May 2020.</u>
- 1.3. These Regulations define the terms and conditions for participation in the Corona-Tales art contest (hereinafter referred to as the 'Contest') and its procedure.

#### 2. Founders of the Contest

2.1. The Contest was founded by Sakhalin Energy.

#### 3. Organising Committee and Expert Jury of the Contest

- The Organising Committee of the Contest (hereinafter referred to as the Organising Committee) is formed and approved by the founders of the Contest.
- The Organising Committee has the right to amend the Regulations on the Contest, as well as to approve additional categories of the Contest, depending on submitted applications for participation.
- The Contest Expert Jury composition is coordinated and approved by the founders of the Contest.
- Decisions made by the Expert Jury, as well as the voting results are final and not subject to revision.

#### 4. Purpose of the Contest

- Unite the employees of the company and contractors working at the company's facilities under the Sakhalin-2 project and their family members.
- Maintain a positive psychological atmosphere in the company and keep up the spirits of employees who are forced by circumstances to work according to changed work schedules during the high alert period as an additional measure to prevent the spread of the COVID-19 disease.
- Disclose and support the development of creative potential, promote the creative initiatives of employees working in the company and their family members.

#### 5. Contest Participants

The Contest is open to:

- employees of the company;
- employees of manpower agencies;
- employees of contracting organisations working at the company's production facilities;
- children of the above employees.

#### 6. Categories

The Contest is held in the following approved Categories:

1. **Best Picture**: a picture representing the hero of any fairy tale or another fictional character who defeats the coronavirus.

The picture can be executed in any painting technique, including graphic. Entries are accepted by e-mail in the form of scanned or photographed copies in the \*jpeg or \*.pdf formats. The size of the file shall not exceed 5 Mb. A label with information on the participant shall be attached to the front side of the picture in the lower right-hand corner (the full name of the person who painted the picture or the employee of the company / recruitment agency / contracting organisation whose child painted the picture, the age of the person who painted the picture, the name of the organisation, the city of residence, the title of the picture).

Entries will be evaluated according to the following criteria:

- conformity with the theme of the Contest;
- originality of the concept;
- composition;
- artistic expressiveness of the picture;
- creative manner.
- 2. **Best Story**: a fictional story in any literary genre about a hero who defeats the coronavirus.

Entries are accepted by e-mail in the \*.docx or \*.pdf format, in Times New Roman font style, font size 12, spacing 1.5. The maximum size of a story is 2 pages.

Information about the participant (the full name of the author or the employee of the company / recruitment agency / contracting organisation whose child wrote the story, the age of the author, the name of the organisation, the city of residence, the title of the story) shall be indicated at the beginning of the document. Entries will be evaluated according to the following criteria:

- originality and implementation of the concept;
- conformity with the theme of the Contest; completeness of theme disclosure;
- style and originality.

Applicants can submit only pictures and/or stories which have been created specifically for participation in the Contest and have never been published before.

Each participant can submit no more than three entries for the Contest. Both individual and group works are accepted.

Each entry must contain full information about the author / group of authors, and the name of the relevant Category of the Contest (see Section 8).

Winners will be selected in each Contest Category.

The Contest entries will be published on the internal website of the company and in the Vesti newsletter. The best entries will be awarded with prizes.

#### 7. Contest Terms and Conditions, Procedure and Format

7.1. Entries shall be e-mailed to the Corporate Affairs Department from 21 April to 25 May 2020 at ea@sakhalinenergy.ru

- 7.2. The Contest is held in three stages:
- Stage 1—acceptance and preliminary evaluation of entries.
- Stage 2—selection of winners.
- Stage 3—awards ceremony.

*Note:* entries accepted for the Contest will be evaluated by the Expert Jury members in the Categories defined by these Regulations. Winners will be awarded with prizes and First, Second and Third Degree diplomas.

The People's Choice Award will be given to the entry selected by employees of the company / recruitment agencies / contracting organisations and their family members by on-line voting.

7.3. The time and place of the awards ceremony will be announced 7 days before the event. The awards will be handed to the corresponding Contest participants or their legal representatives.

#### 8. Requirements

- 8.1. Each participant can submit no more than three pictures and/or stories for the Contest.
- 8.2. Each entry must be accompanied with an annotation in the form given below:

#### 9. Copyright. Personal Data

9.1. The Contest participant / group of participants is liable for respecting the copyright of the picture / story submitted for the Contest.

- 9.2. By sending their entry / entries for participation in the Contest, the participant / group of participants gives their consent to posting the entry / entries on the Internet by the Contest founders, using the entry / entries in television programmes, artistic creative projects, etc.). Additionally, the participant / group of participants shall give their consent to the use of their works in the form given in Appendix 1.
- 9.3. By sending their works for the Contest, participants / their legal representatives give their consent to the processing of their personal data, in particular: the name, the patronymic, the surname, the year of birth and other personal data communicated to the organisers of the Contest.

#### 10. Recognitions and Awards

- 10.1. The Expert Jury can refrain from awarding one or more prizes.
- 10.2. The Expert Jury has the right to award a participant with a special prize.
