At the beginning of the meeting, Ekaterina Meger warned those present that the meeting would be audio recorded for the minutes (the minutes of previous meetings are available on the company's website).

Ekaterina Meger spoke about the activities under the Sakhalin-2 project, including the major shutdown in 2021 (video), about the benefits from the implementation of the Sakhalin-2 project for Sakhalin Oblast, and the company's personnel structure.

Sergey Vinogradov informed the public about the Production Environmental Control Programme, the Environmental Monitoring and Biodiversity Conservation Programme, and the company's preparedness for emergency response.

Ekaterina Meger spoke about the social performance of Sakhalin Energy.

The company representatives recorded all questions asked during the meeting.

Question <i>(in the wording used by the speakers)</i>	Answer
Has the company retained the Scholarship Programme?	Yes, the programme is ongoing. This year, 22 people participated in the Scholarship Programme.

<p>To what countries did the company supply oil in 2021?</p>	<p>The Asia-Pacific region is the market for the supply of hydrocarbons from the Sakhalin-2 project. For the full list of countries, see the 2020 Sustainable Development Report (there were printed copies at the meeting).</p>
<p>Are there any similar LNG production projects in the central part of Russia?</p>	<p>To date, there are only two large-scale LNG plants in Russia: as part of the Sakhalin-2 project and the Yamal LNG project.</p>
<p>Does any tax money from the Sakhalin-2 project go to the district budget?</p>	<p>The company pays all taxes in accordance with the laws of the Russian Federation, in particular, with the RF Tax Code and the Production Sharing Agreement. The budget of the Nogliki District receives taxes from contractors and subcontractors working under the Sakhalin-2 project (for example, personal income tax), as well as payments made by Sakhalin Energy for the lease of land used for the company's facilities. The presentation shows only tax payments made by Sakhalin Energy itself, excluding payments from contractors and subcontractors.</p>
<p>It has been quite a long time since the last cartoon about Senya was released.</p>	<p>Two new cartoons –Virus Shall not Pass, and Underwater Explosive Exercises – were released in 2021.</p>
<p>We are looking forward to the signing of the fourth SIMDP.</p>	<p>The signing of the trilateral agreement has been scheduled for Q4 2021. The date will be appointed by agreement of all parties. The launch of SIMDP-4 will be announced on the programme website and in the printed media; a corresponding information message will be mailed out to all stakeholders.</p>
<p>We really like the books that you publish based on the results of your research. Are you going to publish a book on the results of bird monitoring on the Chayvo Spit?</p>	<p>The results of this monitoring were included in The Birds of Sakhalin. The company does not plan to publish any additional book just now.</p>
<p>How is the vaccination against COVID-19 going at the company? Have 100% employees been vaccinated?</p>	<p>Vaccination is not obligatory for Sakhalin Energy employees. Employees themselves make decisions about whether to get vaccinated. Currently, the level of collective immunity is different at different production facilities of the company. It is more than 75% (including contractor employees) at some of them. The company is conducting an active awareness-raising campaign to promote vaccination.</p>
<p>Does the company comply with the orders of the local department of Rospotrebnadzor?</p>	<p>The company fully complies with all requirements of the government authorities of the Russian Federation.</p>

At the end of the meeting, Ekaterina Meger asked the meeting attendees to provide a feedback in the questionnaire and complete a survey on the effectiveness of Sakhalin Energy's communications.
